How long is the data kept?

The data is only kept for the time strictly necessary:

- the execution of the services
- To comply with legal and regulatory constraints, particularly in terms of managing disputes;
- Geolocation data: only for the duration of the navigation session.

What means are used to ensure your data's safety?

LODECOM SAS is particularly vigilant about the security of your data. A security policy is in place to define the working methods and technical protection rules to be implemented. Here are a few examples of the security measures we have implemented:

Log Data
